OWNS AND OPERATES A RONALD MCDONALD HOUSE IN WILMINGTON, DE TO PROVIDE SAFE AND TEMPORARY HOUSING TO FAMILIES OF SERIOUSLY OR CHRONICALLY ILL OR INJURED CHILDREN WHO MUST LEAVE THEIR LOCAL COMMUNITIES TO SEEK SPECIALIZED MEDICAL TREATMENTS AT WILMINGTON AREA HOSPITALS. THE RONALD MCDONALD HOUSE OF DELAWARE OPENED ON JUNE 7, 1991. THE HOUSE HAS 50 GUEST ROOMS AND SERVED 1726 FAMILIES IN 2017. FAMILIES ARE ASKED TO CONTRIBUTE \$15 A NIGHT. HOWEVER, NO ONE IS TURNED AWAY DUE TO AN INABILITY TO PAY.
